SORSOGON II ELECTRIC COOPERATIVE (SORECO II) is in need of an eligible RE power supplier that can supply 2 MW baseload and 2 MW peaking RE Power Supply to commence this 3<sup>rd</sup> quarter of 2023 whose specific start date of delivery will be subject upon the issuance of ERC's approval. This power supply shall be for SORECO II's compliance with the Renewable Portfolio Standards (RPS) and to meet the demand of its captive consumers.
