RB Resolution No. 2021-04 APPROVAL OF THE 2020 PERFORMANCE SCORECARD ACCOMPLISHMENT REPORT AND ITS SUBMISSION TO THE GOVERNANCE COMMISSION FOR GOCCS (GCG)

Pursuant to Section 4(s) of the Presidential Decree (P.D.) No. 269, as amended; and, Section 5 of Republic Act (R.A.) No. 10531 or the *Powers, Functions and Privileges of the National Electrification Administration,* the NEA is authorized and empowered to exercise such powers and do such things as may be necessary to carry out the business and purposes for which the NEA was established, or which from time to time may be declared by the Board of Administrators as necessary, useful, incidental or auxiliary to accomplish such purposes; and Section 5 of P.D. No. 269, all of the powers of the NEA shall be vested in and exercised by the Board of Administrators;

WHEREAS, the request is the approval of the 2020 Performance Scorecard Accomplishment Report and its Submission to the Governance Commission for GOCCs (GCG).

WHEREAS, under the GCG Memorandum Circular No. 2017-02 indicates that the performance of a GOCC shall be evaluated based on a Performance Scorecard duly adopted by its Governing Board and approved by the Commission. The achievement of organizational targets based on the Performance Scorecard shall serve as the basis for the following:

- Determining the grant of Performance-Based Bonus (PBB) and Performance-Based Incentive (PBI);
- Determining whether Appointive Directors are eligible for reappointment; and
- Ascertain whether a GOCC should be reorganized, merged, streamlined, abolished or privatized.

Accordingly, GCG Memorandum Circular No. 2019-02 provides that in order for a GOCC to be eligible for the grant of PBB, it must achieve a weighted average score of at least 90% in its Performance Scorecard, among others.

The Board approved the 2020 Performance Scorecard through Board Resolution No. 2019-111. However, GCG
