Hereunder are the functions of the EECO, EEC Focal Person and the EECC:

A. EECO

1. Shall prepare, formulate and submit to the Administrator the design, plan, implementation, monitoring and evaluation scheme for the Energy Efficiency and Conservation Plan (EECP) consistent with the Government Energy Management Program (GEMP); and
2. Shall submit a monthly energy performance report to the Department of Energy (DOE).

B. EEC Focal Person

1. Shall assist the EECO in the implementation of the GEMP;
2. Shall lead in the implementation of the EECP; and

3. Shall provide reports to the EECO such as the monthly electricity and fuel consumptions.

C. EECC

1. Shall submit to the undersigned a proposal on policies and guidelines, drafting of EECP, best practices and procedures, strategies of implementation, monitoring and evaluation, periodic comparative analysis report on energy savings by units, among others.
2. Shall submit monthly reports to determine efficiency in the use of energy for the duration of the implementation.

2. Oversee unplugging of all electrical appliances before the end of the office hours;

3. Report any breach in the infrastructure or existing guidelines, rules and regulation that may jeopardize the implementation of the energy conservation and austerity measures;
4. Monitor observance in the proper use of official vehicles and fuel; and
5. Recommend continuing energy conservation and austerity measures.

All expenses to be incurred in the performance of their duties shall be charged against the proper funds of this office subject to the usual accounting and auditing rules and regulations.
