**SUBJECT : Creation of Task Force (TF): Operation "Bantay Kuryente"  
2007 Elections**

In compliance with NEA Memorandum dated 30 April 2007 re: Uninterrupted and Reliable Power for Elections 2007 and as counterpart of NEA-Task Force Halalan headed by Deputy Administrator Pablo Pan III and assisted by Director Jose H. Seguban, Jr., you are enjoined to create your own Task Force: Operation "Bantay Kuryente" which shall begin its operation on 11 May and end by 19 May 2007. The Task Force shall do the following:

- Ensure uninterrupted/continuous supply of power particularly in polling centers
- Restore power immediately in case of interruptions
- Check and monitor distribution line facilities to avert possible interruption
- Record all interruptions/outages through a regular report; and
- Coordinate with local NPC and TransCo representatives as necessary.

Other than the General Manager, a designated Task Force Head should be on call 24/7 to oversee the activities of the following groups (you may have two (2) TF Heads):

- Group A - Administrative Team  
This group is office-based and should be provided with communications facilities much as handheld radio, cellphone, and the like.
- Group B - Linemen Team (may be composed to as many as needed)  
This group is roving, particularly spot polling places as well as be provided with communications equipment as above.

For this special exercise, your lines personnel, including your barangay electricians, should be called to duty.

The tasks of these groups are:

- Report outages (for this purpose, an outage is one which lasts 2 minutes or more) as they happen to the NEA-Task Force Center to these numbers:
