SUBJECT :

Power Task Force: Operation Bantay Kuryente

In relation with NEA Memorandum dated 15 April 2010 re: Ensuring Adequate and Reliable Electric Power Supply Before, During and After the 2010 Automated National and Local Elections, please be advised that the NEA and the EC counterpart organized Power Task Force: Operation Bantay Kuryente shall begin its operation on 7 May 2010 and end by 12 May 2010. The Task Force shall do the following:

- Ensure uninterrupted/continuous supply of power particularly in polling centers;
- · Restore power immediately in case of interruptions;
- Check and monitor distribution line facilities to avert possible interruption;
- · Record all interruptions/outages through a regular report; and
- Coordinate with local NPC and NGCP representatives as necessary

Other than the General Manager, a designated Task Force Head should be on call 24/7 to oversee the activities of the following groups:

Group A -

Administrative Team

This group is office-based and should be provided with communications facilities such as handheld

radio, cellphone and the like

Group B

Linemen Team (maybe composed to as many as needed)
This group is roving, particularly spot polling
places as well as be provided with
communications equipment as above

Two (2) Task Force heads maybe assigned to supervise each of the two groups. Your lines personnel, including your barangay electricians should also be called to duty for this special exercise.

The tasks of these groups are:

 Report outages (for this purpose, an outage is one which lasts 2 minutes or more) as they happen to the NEA-Task Force Center to these numbers:
