Reference is made to our Advisory dated 21 January 2010 (copy attached) informing all electric cooperatives (EC) of spurious attempts of some individuals to solicit funds for non-existent projects by using the name and persona of DOE Secretary Angelo T. Reyes.

Our immediate and timely issuance of the said Advisory had forewarned our ECs against these fake solicitations, thus preventing effectively the proliferation of such.

Upon request of Secretary Reyes, attached is a copy of his memorandum dated 15 February 2010 regarding his official denouncement of any illegal solicitation/misrepresentation with the ECs or any party.
