SUBJECT	:	DOE Memorandum on Unscrupulous Solicitations

Attached is a copy of the memorandum dated 26 September 2016 issued by DOE Secretary Alfonso G. Cusi, warning all concerned employees of DOE and attached agencies against unscrupulous solicitations being made using his name/position.

It was stated in the said memorandum that the DOE does not authorize nor tolerate such acts. Encounters/attempts on such schemes are advised to be reported immediately to DOE (02) 840-2008 / (02) 840-2134 - Office of the Secretary or (02) 840-2067 - Consumer Welfare Hotline, the nearest police station or through the Philippine National Police Hotline 911.

Please note that NEA had issued an earlier advisory dated 28 July 2016 regarding the same concern.

This is to reiterate the previous warning regarding several reports that certain unscrupulous individuals are using the name of the Secretary or other DOE officials to ask for donations/solicitations for certain projects, events or programs to extort money or gain favors.

Please be advised that the Department of Energy (DOE) does not authorize nor tolerate such acts. The DOE strictly adheres to the Code of Conduct and Ethical Standards for Public Officials and Employees (Republic Act 6713) which prohibits officials and employees from soliciting or accepting money or anything of monetary value from any person.

Individuals who have encountered such schemes are advised to immediately report the matter to the DOE (02) 840-2008 / (02) 840-2134 – Office of the Secretary or 8402067 – Consumer Welfare Hotline), the nearest police station or through the Philippine National Police Hotline 911.

In addition, we encourage all agencies, bureaus, services and offices to disseminate this warning to all industry stakeholders for information
