**MEMORANDUM No. 2016-015**

**TO : ALL ELECTRIC COOPERATIVES (ECs)**

**SUBJECT : Calendar Year 2015 EC Overall Performance Assessment and Size Classification**

The ECs' performance level for Calendar Year 2015 shows relatively impressive ratings as NEA demonstrates commitment to service excellence and public governance, and aims for breakthrough achievements in the rural electrification program.


For the period under review, assessment reflected the following:

1. Twenty seven (27) ECs belonging to Regions VI, VII and CARAGA all attained AAA rating, thus, earning the most outstanding performance as a region. This indicates a strong collective leadership and teamwork among ECs in their respective regions.
2. AAA ECs increased to 70 from 56 in the past year while eleven (11) are rated D.
3. Fifty five (55) ECs were able to maintain AAA rating. Fifteen (15) ECs were able to improve their rating to AAA from either AA, A and B.

On the Size Classification of ECs, the number of Mega Large increased to fifty eight (58). Two (2) Extra Large ECs improved to Mega Large while two (2) improved from Large to Extra Large and another one (1) from Medium to Large. There are four (4) Medium and five (5) Small Classification ECs.

We congratulate those ECs which were able to garner AAA rating. All considered, the best step to take is for NEA and ECs to remain as steadfast partners to ensure continuity of the program implementation, compete and survive in the competitive environment and respond to the demands of our member-consumers.

Finally, the attached result of the 2015 EC Overall Performance Assessment and Size Classification shall serve as the bases for the upward and downward implementation of per diems and allowances. Such adjustment shall take effect July 1, 2016.
