RESOLUTION NO. 100-S. 2023
(Competitive Bidding)

Recommending Award of Contract to DGL Veracity Systems Corporation for the Procurement of Supply, Delivery, Installation, and Commissioning of Closed Circuit Television (CCTV) System for NEA Building

WHEREAS, on 19 September 2023, the Technical Working Group (TWG) endorsed to the Bids and Award Committee (BAC) the Terms of Reference for the **Procurement of Supply, Delivery, Installation, and Commissioning of Closed Circuit Television (CCTV) System for NEA Building**;¹

WHEREAS, the General Services Division prepared the Purchase Request No. 23-10-155 dated 05 October 2023 for the bidding of the above procurement;²

WHEREAS, the Approved Budget for the Contract (ABC) for the aforesaid procurement amounting to **Three Million Pesos (PhP3,000,000.00)** was certified available by the Corporate Resources and Financial Services of NEA, chargeable against the **Capital Outlay under Furniture, Fixtures and Other Equipment** of FY2023 Annual Procurement Plan (APP);³

WHEREAS, the following bidding activities for the aforesaid procurement were conducted by the BAC, as follows;

On 09 October 2023, the **Pre-Procurement Conference** was held by the BAC to review, amend and agree on the Terms of Reference and Bidding Document prepared by the Technical Working Group (TWG);⁴

On 12 October 2023, the **Invitation to Bid** for the above-mentioned procurement was posted/published on the PhilGEPS, NEA website, and conspicuous place, in accordance with Section 21.2 of the 2016 Revised Implementing Rules and Regulations (IRR) of R.A. 9184;⁵

On 20 October 2023, the **Pre-Bid Conference** was conducted at the Cultural Affairs Room, 2nd Floor, NEA Bldg., which was participated by the BAC, Technical Working Group (TWG), BAC-Secretariat and eight (8) prospective bidders, namely: Palmer-Asia Inc., K26 General Merchandise, One Jrand Corp. Industry, IT Solutions, Inc., Riley Corporation, Velocity, DGL Veracity System Corp., and Multi-Line Bldg., System, Inc.;⁶

On 24 October 2023, Supplemental Bid Bulletin No. 23-02 was posted on the NEA Website to address the issue in the Bidding Documents and Terms of Reference in accordance with Section 22.5.2 of the Revised Implementing Rules of RA 9184;⁷

On 07 November 2023, during the **Submission of Bids**, Multi-Line Bldg. System, Inc., One Jrand Corp., Industry, Riley Corporation, DGL Veracity System Corp., and Palmer-Asia, Inc submitted their bids;⁸

On the same date, the **Opening of Bids** was conducted face to face which was participated by the BAC, TWG, BAC-Secretariat, Multi-Line Bldg. System, Inc., One Jrand Corp., Industry, Riley Corporation, DGL Veracity System Corp., and Palmer-Asia, Inc.;⁹

The submitted technical component envelope of the five (5) bidders consisting of legal, technical, and financial documents, was opened. Multi-Line Bldg. System, Inc., Industry, Riley Corporation, DGL Veracity System Corp., and Palmer-Asia, Inc. passed the preliminary evaluation by the BAC using the non-discretion "**pass/fail**" criterion while One Jrand Corp. Industry's submitted document was not compliant to the bid format and exceeded the ABC, thus declared ineligible;¹⁰

Having complied with the preliminary evaluation of the technical components, their financial bid components were subsequently opened, yielded the financial bid amounts which are within the ABC of **Three Million Pesos (PhP3,000,000.00)** as follows;¹¹

By virtue of BAC Resolution Nos. 85-S.2023 and 93-S.2023, respectively, the BAC directed the TWG to conduct the **bid evaluation and post-qualification** of the bids submitted by the four (4) bidders pursuant to Sections 32 and 34 of the 2016 Revised IRR of RA 9184;¹²

On 22 November 2023, the TWG submitted its Bid Evaluation Report declaring DGL Veracity Systems Corporation as the Lowest Calculated Bidder for the Supply, Delivery, Installation, and Commissioning of Closed Circuit Television (CCTV) System for NEA Building for the aforesaid procurement and thereby recommended for post-qualification;¹³

Likewise, the Abstract of Bids As-Calculated was signed by the BAC with the following ranking:

On 12 December 2023, the TWG submitted its **Post-Qualification Report** indicating that the technical and financial components of bids submitted by DGL Veracity Systems Corporation for the Supply, Delivery, Installation, and Commissioning of Closed Circuit Television (CCTV) System for NEA Building is responsive and therefore recommended as being the **Lowest Calculated and Responsive Bidder (LCRB) for the Supply, Delivery, Installation, and Commissioning of Closed Circuit Television (CCTV) System for NEA Building** for the TWG endorsed to the Bids and Award Committee (BAC) the Terms of Reference for the Procurement of Supply, Delivery, Installation, and Commissioning of Closed Circuit Television (CCTV) System for NEA Building;¹⁵

NOW, THEREFORE, be it resolved, as it is hereby resolved by the BAC to declare DGL Veracity Systems Corporation the Lowest Calculated and Responsive Bidder (LCRB) for the Procurement of Supply, Delivery, Installation, and Commissioning of Closed Circuit Television (CCTV) System for NEA Building and recommend to the Administrator the award of contract to DGL Veracity Systems Corporation;¹⁶

RESOLVED FINALLY, to request the approval of the Administrator, as provided for in RB Resolution No. 2020-74 (1), to sign the following documents:¹⁷


- a. The Notice of Award (NOA) in favor of DGL Veracity Systems Corporation for the Procurement of Supply, Delivery, Installation, and Commissioning of Closed Circuit Television (CCTV) System for NEA Building in the amount of **Two Million Two Hundred Eighty Thousand Pesos (PhP2,280,000.00)**.¹⁸
