RESOLUTION NO. 115-S. 2023

(Competitive Bidding)

Recommending Award of Contract to Pilipinas Micro-Matrix Technology (PMT Joint Venture) Inc. for the Procurement of Operations and Maintenance (O&M) Services and Cloud Subscription Services for the NEA Business Intelligence Technology (NEA-BIT) System (Re-Bidding)

WHEREAS, on 20 October 2023, the Technical Working Group (TWG) endorsed to the Bids and Award Committee (BAC) the Terms of Reference for the Procurement of Operations and Maintenance (O&M) Services and Cloud Subscription Services for the NEA Business Intelligence Technology (NEA-BIT) System (Re-Bidding);1

WHEREAS, the General Services Division prepared the Purchase Request No. 23-08-119 dated 16 August 2023 for the bidding of the above procurement;2

WHEREAS, the Approved Budget for the Contract (ABC) for the aforesaid procurement amounting to Six Million Five Hundred Thousand (PhP6,500,000.00) for the Procurement of Operations and Maintenance (O&M) Services for the NEA Business Intelligence Technology (NEA-BIT) and Five Million Pesos (PhP5,000,000.00) for the Procurement of Cloud Subscription Services for the NEA Business Intelligence Technology (NEA-BIT) was certified available by the Corporate Resources and Financial Services of NEA, chargeable against the approved budget for Other Professional Services and ICT Subscription as contained in the FY 2023 and FY 2024 Annual Procurement Plan and General Appropriations Act.;3

WHEREAS, the following bidding activities for the aforesaid procurement were conducted by the BAC, as follows;

On 28 September 2023, the BAC declared the 1st FAILURE OF BIDDING as per BAC Resolution No. 63 and recommended to the HoPE the RE-BIDDING as per Section 35 of the 2016 Revised IRR of RA 9184;4

On 31 October 2023, the Pre-Procurement Conference was held by the BAC to review, amend and agree on the Terms of Reference and Bidding Document prepared by the Technical Working Group (TWG);5

On 07 November 2023, the Invitation to Bid for the above-mentioned procurement was posted/published on the PhilGEPS, NEA website, and conspicuous place, in accordance with Section 21.2 of the 2016 Revised Implementing Rules and Regulations (IRR) of R.A. 9184;6

On 15 November 2023, the Pre-Bid Conference was conducted at the Cultural Affairs Room, 2nd Floor, NEA Bldg., which was participated by the BAC, Technical Working Group (TWG), BAC-Secretariat and four (4) prospective bidders, namely: SVI Software Services Corporation and SVI Technologies, Inc. Joint Venture and Pilipinas Micro-Matrix Technology (PMT Joint Venture) Inc., PPLDT and Indra PH;7

On 28 November 2023, during the Submission of Bids, SVI Software Services Corporation and SVI Technologies, Inc. Joint Venture and Pilipinas Micro-Matrix Technology (PMT Joint Venture) Inc. submitted their bids;8

On the same date, the Opening of Bids was conducted which was participated by the BAC, TWG, BAC Secretariat, SVI Software Services Corporation and SVI Technologies, Inc. Joint Venture and Pilipinas Micro-Matrix Technology (PMT Joint Venture) Inc.;9

WHEREAS, during the evaluation, using the non-discretionary Software Services Corporation criterion. SVI Technologies, Inc. Joint Venture passed the submitted Certification but failed the submission of the required documents for the SEC Certificate, Mayor's or Business Permit and the Tax Clearance while PMTI passed the eligibility and technical preliminary evaluation; 10

On 30 November 2023, SVI Software Services Corporation and SVI Technologies, Inc. Joint Venture submitted their request for reconsideration wherein the BAC issued Resolution No. 97-S.2023 considering the summary as substantial compliance of the requirements and allowing SVI Software Services Corporation and SVI Technologies, Inc. Joint Venture to participate and directing the BAC-TWG to conduct the bid evaluation on the second envelope or the financial documents submitted by the SVI Software Services Corporation and SVI Technologies, Inc. Joint Venture. 11

Having complied with the preliminary evaluation of the technical components, the financial bid component was subsequently opened, yielding the financial bid amount which is within the ABC of Eleven Million Five Hundred Thousand Pesos (PhP11,500,000.00) as follows;12

On 13 December 2023, the TWG submitted its Bid Evaluation Report declaring Pilipinas Micro-Matrix Technology (PMT Joint Venture) Inc. as the Lowest Calculated Bidder for the Operations and Maintenance (O&M) Services and Cloud Subscription Services for NEA Business Intelligence Technology (NEA-BIT) System for the aforesaid procurement and thereby recommended for post-qualification;14
