



## TECHNICAL SPECIFICATIONS

### PROCUREMENT OF BRAND NEW ONE (1) UNIT PASSENGER VAN

#### I. BACKGROUND:

The National Electrification Administration's (NEA's) 2023 Approved Capital Outlay for Office Furniture, Fixtures and Other Equipment (CO-OFFE), as contained in RA11936 or FY2023 General Appropriations Act, includes procurement for one (1) unit Passenger Van.

#### II. OBJECTIVE:

To procure the motor vehicle for official use of NEA, one (1) unit Passenger Van for transport of personnel/visitors for activities and other official functions, as well as for shuttle service of NEA employees.

#### III. APPROVED BUDGET FOR THE CONTRACT (ABC):

The ABC of One Million Eight Hundred Fifty Thousand Pesos (₱1,850,000.00) inclusive of all taxes shall be charged against the capital outlay under the Transportation Equipment of APP FY2023.

## **V. REQUIREMENTS:**

Upon delivery of the vehicles:

- Basic tool kit with complete set of tools, new spare tire, early warning device, magic tint, floor matting and rain visors
- Free Land Transportation Office (LTO) registration for the first three (3) years
- Free one (1) year Comprehensive Insurance and CTPL (GSIS)
- Free labor and supplies/materials on preventive maintenance services within the first 1,000/1,500kms; 5,000kms and 10,000kms as the minimum
- With seat cover
- Rust proofing/undercoating
- Other freebies, if any.

## **VI. QUALIFICATIONS OF THE DEALER AND OTHER REQUIREMENTS:**

- Must be at least five (5) years in the business as authorized dealer of brand new vehicles.
- Must have counterpart in Luzon, Visayas and Mindanao.
- Must submit a list of accredited repair service centers within Metro Manila, Luzon, Visayas and Mindanao.


### **Warranty**

- Minimum of three (3) years or 100,000 kilometers whichever comes first, on both parts and labor.

## **VII. DELIVERY TERMS:**

The delivery period shall be within thirty (90) calendar days upon receipt of the approved Notice to Proceed (NTP) at the NEA Office, Quezon City.


