



**REQUEST FOR QUOTATION  
(Negotiated Procurement-Two Failed  
Biddings)**

**DESIGN, SUPPLY, INSTALLATION AND COMMISSIONING OF  
SOLAR POWERED LEVEL II POTABLE WATER SYSTEM FACILITY IN  
LEBAK, SULTAN KUDARAT**

1. In view of the two (2) failed biddings, the **National Electrification Administration (NEA)**, through its Special Bids and Awards Committee (SBAC), invites PhilGEPS registered suppliers to participate in the **Negotiated Procurement-Two Failed Biddings** of the Design, Supply, Installation, and Commissioning of Solar- Powered Level II Potable Water System Facility in Lebak, Sultan Kudarat, in accordance with Section 53.1 of the Revised Implementing Rules and Regulations (RIRR) of the Republic Act No. 9184.
2. The NEA, through the European Union Access to Sustainable Energy Project (EU-ASEP) Financing Agreement, applied the sum of **Six Million Four Hundred Sixty Five Thousand Three Hundred Fifty Eight Pesos and 90/100 (Php6, 465,358.90)**, as Approved Budget for the Contract (ABC).
3. The duration of the project is for four (4) months from the receipt of Notice to Proceed. The schedule of activities are as follows:
