RESOLUTION NO. 81-S. 2023
(Competitive Bidding)

Recommending Award of Contract to Alpine Motors Corporation and Toyota Silang Cavite for the Procurement of Two (2) Units Brand New Motor Vehicles

WHEREAS, on August 31, 2023, the Technical Working Group (TWG) endorsed to the Bids and Award Committee (BAC) the Terms of Reference for the **Procurement of Two (2) Units Brand New Motor Vehicles**;¹

WHEREAS, the General Services Division prepared the Purchase Request No. 23-09-132 dated 07 September 2023 for the bidding of the above procurement;²

WHEREAS, the Approved Budget for the Contract (ABC) for the aforesaid procurement amounting to **Two Million Five Hundred Eighty-Six Thousand One Hundred Fifty Pesos (P2,586,150.00)** for Lot A and **One Million Three Hundred Eighty-Three Thousand Two Hundred Pesos (P1,383,200.00)** for Lot B was certified available by the Corporate Resources and Financial Services of NEA, chargeable against the **Motor Vehicles (Capital Outlay)** funds of FY2023 Annual Procurement Plan (APP);³

WHEREAS, the following bidding activities for the aforesaid procurement were conducted by the BAC, as follows;

On 06 September 2023, the **Pre-Procurement Conference** was held by the BAC to review, amend and agree on the Terms of Reference and Bidding Document prepared by the Technical Working Group (TWG);⁴

On 12 September 2023, the **Invitation to Bid** for the above-mentioned procurement was posted/published on the PhilGEPS, NEA website, and conspicuous place, in accordance with Section 21.2 of the 2016 Revised Implementing Rules and Regulations (IRR) of R.A. 9184;⁵

On 20 September 2023, the **Pre-bid Conference** was conducted at the Cultural Affairs Room, 2nd Floor, NEA Bldg., which was participated by the BAC, Technical Working Group (TWG), BAC-Secretariat and two (2) prospective bidders, namely: Nissan Commonwealth, and Alpine Motors Corporation;⁶

On 02 October 2023, during the **Submission of Bids**, SJ Legacy Motors, Alpine Motors Corporation, and Toyota Silang Cavite submitted their bids;⁷

On the same date, the **Opening of Bids** was conducted face to face which was participated by the BAC, TWG, BAC Secretariat, SJ Legacy Motors, Alpine Motors Corporation, and Toyota Silang Cavite;⁸

The submitted technical component envelope of the two (3) bidders consisting of legal, technical, and financial documents, was opened and passed the preliminary evaluation by the BAC using the non-discretion "**pass/fail**" criterion;⁹

Having complied with the preliminary evaluation of the technical components, their financial bids component were subsequently opened, yielded the financial bid amounts which are within the ABC of **Two Million Five Hundred Eighty-Six Thousand One Hundred Fifty Pesos (₱2,586,150.00)** for Lot A and **One Million Three Hundred Eighty-Three Thousand Two Hundred Pesos (₱1,383,200.00)** for Lot B, as follows;¹⁰

By virtue of BAC Resolution Nos. 71-S.2023 and 73 -S.2023, respectively, the BAC directed the TWG to conduct the **bid evaluation** and **post-qualification** of the bids submitted by the two (2) bidders pursuant to Sections 32 and 34 of the 2016 Revised IRR of RA 9184;¹¹

On 11 October 2023, the TWG submitted its Bid Evaluation Report declaring Alpine Motors Corporation as the Lowest Calculated Bidder for Brand New One (1) Unit Sports Utility Vehicle (SUV) (Lot A) and Toyota Silang Cavite Inc. as the Lowest Calculated Bidder for Brand New One (1) Unit Multi-Purpose Vehicle (MPV) (Lot B) for the aforesaid procurement and thereby recommended for post-qualification;¹²

Furthermore, based on the detailed Bid Evaluation conducted by the TWG, SJ Legacy Motors, Inc. failed to meet the five (5) years requirement in the Invitation to Bid for Lot A;

On 16 October 2023, the BAC sent the **Notice of Post-Qualification** to Alpine Motors Corporation for Brand New One (1) Unit Sports Utility Vehicle (SUV) (Lot A) and Toyota Silang Cavite Inc. for Brand New One (1) Unit Multi-Purpose Vehicle (MPV) (Lot B). Thereafter, Alpine Motors Corporation and Toyota Silang Cavite Inc. submitted the required post-qualification documents within the required period of five (5) days;¹³



Likewise, the Abstract of Bids As-Calculated was signed by the BAC with the following ranking;

On 31 October 2023, the TWG submitted its **Post-Qualification Report** indicating that the technical and financial components of bids submitted by Alpine Motors Corporation for Brand New One (1) Unit Sports Utility Vehicle (SUV) (Lot A) and Toyota Silang Cavite Inc. for Brand New One (1) Unit Multi-Purpose Vehicle (MPV) (Lot B) are responsive and therefore recommended as being the **Lowest Calculated and Responsive Bidders (LCRB) for Brand New Two (2) Units Motor Vehicles** for the TWG) endorsed to the Bids and Award Committee (BAC) the Terms of Reference for the Procurement of Brand New Two (2) Units Motor Vehicles;¹⁴

NOW, THEREFORE, be it resolved, as it is hereby resolved by the BAC to declare Alpine Motors Corporation and Toyota Silang Cavite Inc., the Lowest Calculated and Responsive Bidders (LCRB) for the Procurement of Brand New Two (2) Units Motor Vehicles and recommend to the Administrator the award of contract to Alpine Motors Corporation and Toyota Silang Cavite Inc.;¹⁵

RESOLVED FINALLY, to request the approval of the Administrator, as provided for in RB Resolution No. 2020-74 (1), to sign the following documents:¹⁶

- a. The Notice of Award (NOA) in favor of Alpine Motors Corporation for the Procurement of Brand New One (1) Unit Sports Utility Vehicle (SUV) in the amount of **Two Million Four Hundred Seventy-Seven Thousand Pesos (₱2,477,000.00) for Lot A** and Toyota Silang Cavite Inc. for the Procurement of Brand New One (1) Unit Multi-Purpose Vehicle (MPV) (Lot B) in the amount of **One Million Three Hundred Forty Thousand Pesos (₱1,340,000.00) for Lot B.**¹⁷
