ATTENTION: All prospective bidders for the project.

This Supplemental Bid Bulletin No. 2025-02 dated 31 March 2025 is being issued to clarify, modify, or amend some items/provisions in the *Bidding Documents for LOT I, LOT II, LOT III, LOT IV, and LOT V* relative to the above-entitled project as posted in the National Electrification Administration (NEA) website, ISELCO-I's website, and disseminated to the prospective bidders. Those underlined and in bold letters indicate the revisions or amendments made.

The following items/provisions in the *Invitation to Bid-Public Bidding No. 02, Series of 2025 of the Bidding Documents* are hereby amended to read as follows:

1. For LOT IV-A and LOT IV-B, the new specification for the following items shall be as follows:

For clarification, the sworn attestation stating that the brand has been in existence in the market for at least 10 years under Supplemental Bid Bulletin No. 2025-001 dated 27 March 2025, is hereby included as an additional eligibility requirement specifically in the **Technical Documents: Folder 2 (Envelope I)**.

This Supplemental Bid Bulletin No. 2025-02 shall form part of the previously issued *Bidding Documents for LOT IV-A and LOT IV-B*. Any provisions thereof inconsistent herewith are hereby amended, modified, added, and superseded accordingly.

Finally, all bidders who have submitted their bids prior to the issuance of this Supplemental Bid Bulletin, as well as Supplemental Bid Bulletin No. 2025-01, are hereby informed of their right to modify, amend, or withdraw their respective bids, pursuant to Rule VII, Section 22.5.3 of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184. This

right arises in the event that their bids no longer comply with the amendments or clarifications introduced in the supplemental bid bulletins issued by the Bids and Awards Committee (BAC) following the pre-bid conference.
