SUBJECT :

EXECUTIVE SESSION WITH PS and AGM

Rationale:

Following the previous years' conduct of assessments for challenged Electric Cooperatives (ECs) and dialogues with Project Supervisors (PS), Acting General Managers (AGMs) and Assists through a Roundtable Discussion designated by NEA to turnaround the operations of these ECs, the Management and Consultancy Services Office (MCSO) has planned to undertake Executive Sessions with PS/AGMs and Assists for year 2020.

The Executive Session is designed to provide an exclusive platform for more in-depth dialogue with concerned PS/AGM/Assist on urgent and critical issues and concerns, particularly on those that impede/deter the EC's path towards expected operational improvement.

The global health and economic crises brought about by the COVID-19 pandemic prompted the adoption of massive and unprecedented changes in businesses and people's lifestyles to ensure survival in many countries, including ours. Since the restrictions on travel and social gathering will remain for a long period of time, corresponding adjustments on the programs, projects and activities of companies, whether public or private, will have to be made to cope with the emergence of a "New Normal".

As such, the planned Executive Sessions with PS/AGMs and Assists of MCSO will be conducted through the use of available social media applications. The virtual Executive Sessions will be an effective alternative in the realization of NEA's multi-faceted assistance to ECs, despite community quarantine restrictions.

Objectives:

- 1. Review the performance of PS/AGMs and Assists through their respective Scorecard Accomplishments and Action Plans.
- 2. Evaluate the effectivity of field assignments based on the improvement of EC operational and financial performance and compliances to NEA standards and parameters via Zoom Meetings and other available social media platforms.
- 3. Discuss the urgent issues/concerns affecting the EC and performance of PS/AGMs and Assists in respective field assignments.
- 4. Set directions and raise the bar of individual performance as PS, AGM or Assists.

- 4. Set directions and raise the bar of individual performance as PS, AGM or Assists.
- 5. Provide guidance and assistance in resolving problems and identifying strategies for the improvement of the operational efficiency, financial viability and assurance of power reliability of the ECs for member-consumer-owners' satisfaction through advisories, cellphone consultations, teleconferences, zoom meetings, etc.
- 6. Assess the implementation of the EC Risk Management and Sustainability Plan/Business Continuity Plan (EcRM-SP/BCP) incorporating the COVID-19 Protocols adapting to the "New Normal".

- 4. Implementation of the EC Risk Management and Sustainability Plan/Business Continuity Plan (EcRM-SP/BCP) incorporating the COVID-19 Protocols adapting to the "New Normal".

Each PS or AGM will be given, preferably 10 minutes, at most, for the presentation. A discussion/consultation with the MCSO Team, together with the Department Managers in the ECMS Sector (e.g. MCSO, IDD and ECAD) shall thereafter follow.
