NEA-EC COMMON FOLK'S DAY PROGRAM

I. DEFINITION

The **NEA-EC Common Folk's Day Program** is a joint activity that is aimed to bring the government's *rural electrification program* closer to the member-consumers and other stakeholders.

II. OBJECTIVES

It aims to develop a **well-informed** and **responsible** member-consumers by providing them with enhanced information and education orientations to invoke their **awareness** on the rural electrification program and the current government thrust in the power industry, as well as on operational framework of the ECs.

V. TIMELINE (April to June 2006 and onwards)
