Date of Submission: Not later than three (3) months after the conduct of AGMA

The timely submission of the requests shall ensure the speedy and corresponding action by NEA. It is likewise presumed that these requests/plans have been included in the proposed yearly Cash Operating Budget (COB) prepared by the ECs which are likewise processed by NEA during the 3rd and 4th quarters of every year.

Requests submitted outside of the prescribed period shall no longer be entertained, and shall be processed in the succeeding year's period of submission. As such, the Board of Directors and the General Manager are enjoined to enhance their plans according to the above timelines. Getting the proper approvals and action protect both the ECs and their officials from possible complaints and charges from groups among member-consumers, and from audit disallowances.
