SUBJECT : Forty Thousand Consumer-Connections in the last 40 Days

Congratulations!

We attained 41,678 consumer connections in the last 40 days before the Rural Electrification Program Anniversary on August 6, 2009. One of our build - up activities during the 40th anniversary, the program commenced on June 27 and ended on August 5.

We received the first report on the 4th of July from CEBECO I and ended with the report submissions of LEYECO IV, CENPELCO, SUKELCO, ZANECO and SURNECO at 12 noon of August 7. The 40th connection was registered with the Central Pangasinan Electric Cooperative, Inc. (CENPELCO).

Luzon got the highest consumer connections with 19,906, followed by Mindanao at 11,068 and the Visayas with 10,704. In terms of accomplishment against target, Luzon got the highest with 111%. Visayas made it at 101% while Mindanao is 10% less than the targeted connections. But the turn-over was generally good at 102% as over-all accomplishment.

Highest among regions are Regions III, VII and XII but in terms of percentage versus the expected contribution, Regions II, VII and XII contributed the highest. Below is the distribution by island and region:
