TO : ALL ELECTRIC COOPERATIVES (ECs)

SUBJECT : EC Categorization Assessment in Three Decades (1982-2011)

- \*\*\*\*\*
- I. For the past 30 years, the annual categorization of ECs was conducted by the National Electrification Administration (NEA) to evaluate their operating performance based on established criteria. This set of criteria was revised from time to time to be more responsive and reflective of the obtaining circumstances in the operations of ECs. During the deregulated power environment era pursuant to the Electric Power Industry Reform Act (EPIRA) of 2001, NEA adopted enhanced/revised criteria in 2004, 2008 and 2011. Amortization payment to NEA, system loss, collection efficiency, payment to power supplier/s and transmission company, non-power cost, result of financial operation and level of energization were the parameters used in the categorization.
  - II. The EC Categorization can be divided into two (2) chapters. For the first chapter covering the years 1982 to 1993, Category A was the highest overall rating with D as the lowest. The second chapter started in 1994 where the overall rating scheme was adjusted using Category A+ as the highest and E the lowest.
  - III. To meet the current demands of the power industry and the heightened expectations of the member-consumers and other stakeholders, **NEA adopted a new set of Key Performance Standards (KPS) which shall be implemented starting performance year 2012**. As such, the 2011 EC Categorization shall be the last assessment using this method. This paper was prepared to present an overview of the EC categorization in three (3) decades.
  - IV. The highlights of the assessment based on the attached reports are as follows:
    1. System Loss

Leading the ECs in system loss performance are MORESCO I and CEBECO I for having maintained a single digit mark for the last 30 years. CEBECO III also posted the same level of performance except for three (3) years: 1991 (10.50%), 1993 (12.03%) and 1994 (11.22%). It was followed by BOHECO I

and TIELCO which were able to achieve a single digit system loss for the last 14 consecutive years (1998-2011).

## 2. Collection Efficiency

A review of NEA's available records show that BOHECO I registered 100% collection efficiency for the last 23 consecutive years (1989-2011). CEBECO III and BENECO were able to maintain the same level of performance for the last 18 (1994-2011) and 16 (1996-2011) consecutive years, respectively. Next in the list are CEBECO I, LUELCO and SIARELCO for having posted 100% collection performance for at least 10 consecutive years.

3. During the first run of assessment for performance year 1982, only 14 ECs earned Category A rating while 40 were rated Category D. The ECs' operational performance remarkably improved as reflected in the increase in the number of Category A ECs at 56 as we closed the first chapter in 1993.
4. At the opening of the second chapter, only 25 ECs earned Category A+ while 17 were assessed Category E. It was during the new and restructured NEA starting 2004 where the performance of ECs significantly improved. The number of Category A+ had increased from 45 in 2003 to 59 in 2004. The best ECs' performance record was attained in 2010 when 70 ECs were able to earn a Category A+ rating on top of the 15 which were rated Category A for a total of 85 Category A+ and A ECs.
5. A comparison of the 2010 and 2011 performance level may not be precisely presented because of the difference in the parameters used. An enhanced and more competitive set of criteria was applied for performance year 2011 to provide a transition period in anticipation of more rigorous compliance standards that need to be met starting performance year 2012. However, it is noteworthy to state that it was in 2011 that we achieved the lowest ever national average system loss at 11.87%. Only nine (9) ECs remained in Category E as we closed the EC Categorization assessment method.

## 6. Consistent Outstanding Performing ECs

Two (2) ECs namely: MORESCO I and DASURECO were able to maintain outstanding operational performance for 30 years. They were rated A from 1982 to 1993 and A+ from 1994 up to the last assessment for performance year 2011.

Another six (6) ECs: CEBECO I, CEBECO II, CEBECO III, BOHECO I, SOCOTECO I and ILECO I are next in the list for having earned outstanding performance for the periods under review.

## 7. Best Regions

Region VII demonstrated a very strong collective leadership and teamwork within its region for having maintained all member ECs categorized as A+ for the last eight (8) consecutive years (2004-2011). Region XI is next in the roster of outstanding performers with all member ECs able to achieve Category A+ for four (4) consecutive years (2007-2010). This level of performance was also attained by CARAGA for the last three (3) consecutive years (2009-2011).

## V. Remaining Challenges

During the early years, most ECs in Regions III, V, VIII and the Autonomous Region in Muslim Mindanao (ARMM) were among those which needed more attention to turn their operations around. Through the years, almost all ECs in Regions III and VIII were able to improve their operational performance including significant reduction in system loss and improvement in collection efficiency thereby earning the higher Category A+ or A. However, the culture-based and obtaining concerns in ARMM and Region V remain to be the major challenges that require definite NEA interventions and specific resolution. It is worth mentioning that despite these operational challenges, LASURECO was able to transform from a perennial critically-challenged EC into a reliable distribution utility through a devised holistic approach thus, gained attention and respect from other sectors.

With the end view of further enhancing the viability, credit worthiness and sustainability of the rural ECs as electric utilities, the EC Categorization has come to a close to put forth another assessment tool using a new set of key performance standards.

And finally, all ECs are advised to be more pro-active in order to meet this new set of prescribed performance standards which are imperative to survive competition.
