SUBJECT : Request for Police Assistance for EC Personnel During Disconnection Campaign

Please be informed that in his letter dated 27 August 2013, DOE Secretary Carlos Jericho L. 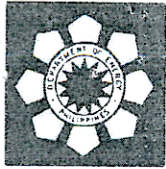

Dear **PDG Purisima**:

In line with our mandate to ensure continuing electric service to all power consumers in the country, the Department of Energy, through the National Electrification Administration, has advised all Electric Cooperatives (ECs) to step up on their electric bill collections to be able to promptly settle their monthly payables with their power providers. For your information, there are 119 ECs nationwide, serving 9.8 million connections. Most of them meet their power obligations, but there are some which may find difficulty in promptly paying their monthly bills due to poor collection and internal conflicts within their franchise area.


It is in this regard that we are requesting police assistance for ECs in the event that they will have to disconnect non-paying consumers. There had been instances in the past that the EC disconnection team had been bodily threatened/hurt. Police presence will ensure peace for all.

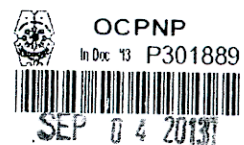
May we kindly request you to advise your regional commands about this arrangement, with the actual request for specific areas to be provided by NEA or the concerned EC at the proper time.

Availability of electric service is very vital to our stable and progressing economy, thus, we do not want to take any chance of failure.

Thank you very much for your continuing support to the Energy Sector.

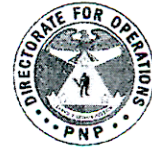
