SUBJECT

: EC Bank Account and Certification for Government Subsidy Funds

The National Government (NG), through the National Electrification Administration (NEA), has been releasing subsidy funds to electric cooperatives (ECs) for the implementation of electrification projects, rehabilitation of damaged distribution facilities and other related projects. Thus, all ECs have been required to maintain separate bank accounts with account name "Barangay/Sitio Electrification Fund or Subsidy Fund or SEP/BLEP Fund" to emphasize that subsidy funds are funds intended solely and exclusively for the government's electrification projects.

To protect these funds from garnishment, all ECs are advised to prepare a Certification (proforma attached) stating that government subsidies released by NEA to ECs have been appropriated for specific purposes pursuant to P.D 269 as amended by P.D 1645 and further amended by RA 10531, and annual General Appropriations Act (GAA) and as such, are specifically exempt from garnishment. The notarized certification shall then be formally submitted to the EC depository bank/s for appropriate disposition.
