SUBJECT : REPRESENTATION, TRAVELLING ALLOWANCE AND PER DIEMS OF MEMBERS OF TASK FORCE


I. Rationale

The NEA is empowered under Section 4 (j) of R.A.10531 to ensure the economic and financial viability and operation of all Electric Cooperatives (ECs). To effectively perform this mandate of addressing the problems on operational efficiency of some ECs, NEA has tapped the services of officials and employees of excellently performing ECs to contribute their expertise in running the affairs of problematic ECs. Thus, for the effective performance of their assigned duties as members of the constituted Task Force, provisions for representation, travelling allowances and Per Diems for Board meetings attended and Committee meetings shall be provided by the recipient ECs to the concerned officials and employees.

- II. Mechanics of Implementation
 - 1) The Per Diem and Allowances to be provided by the recipient EC shall be as follows:
 - a) Representation Allowance Chairman: Php 8,800
 - Chairman: Php 8,800 Members: Php 7,500
 - b) Travelling Allowance Chairman: Php 2,500

Chamman.	1 mp 2,500
Members:	Php 2,500

 c) Per Diems per Board Meeting (not to exceed 2 meetings in a month) Chairman: Php 8,500 Members: Php 7,500



- d) Per Diems for Committee Meeting regardless of number of meetings per month Chairman: Php 2,000 Members: Php 2,000
- e) Air Fare (to and from) shall be shouldered by the recipient EC.
- 2) The payment of these allowances shall be subject to the EC's availability of funds and shall be incorporated in the Cash Operating Budget for the current year.
- 3) The EC Board Resolution shall be submitted to NEA, through the Institutional Development Department, for its approval.

III. Applicability

This Policy is issued subject to existing laws, rules and regulations.


IV. Effectivity
