AMENDMENT TO NEA MEMORANDUM NO. 2018-027

DATED 20 APRIL 2018

The National Electrification Administration (NEA) issued on 20 April 2018 the above subject Memorandum entitled, "DEFERMENT OF DISTRICT ELECTIONS DUE TO 2018 BARANGAY ELECTION AND 2019 NATIONAL AND LOCAL ELECTIONS AND GUIDELINES IN THE CANDIDACY OF EC OFFICIALS AND EMPLOYEES".

Item No. 8 of the said guidelines provides that upon filing of Certificate of Candidacy, the EC officials and employees concerned shall file a leave of absence in the electric cooperative until such time that the election has been concluded, in order to avert the misuse of power/position or use of EC resources in the campaign. During consultation meetings of NEA with Electric Cooperatives Allied Organizations, a concern was raised on the vacancy in the position that will be created due to long duration of leave of absence of the candidate EC officials and employees considering that the filing of candidacy shall start in October 2018.

In view of the intention of Item No. 8 of NEA Memorandum No. 2018-027 above-mentioned, which is to avert the misuse of power/position or use of EC resources in the campaign, the same is hereby amended to read as follows:

"8. Upon THE START OF THE CAMPAIGN PERIOD PRESCRIBED BY THE COMMISSION ON ELECTIONS (COMELEC), EC officials and employees concerned shall file a leave of absence in the electric cooperative until such time that the election has been concluded, in order to avert the misuse of power/position or use of EC resources in the campaign."

This modifies NEA Memorandum No. 2018-027 dated 20 April 2018 and shall take effect immediately upon filing with the University of the Philippines (UP) Law Center pursuant to the Presidential Memorandum Circular No. 11 dated October 9, 1992.
