

RESOLUTION NO. 01 Series of 2019

RECOMMENDING APPROVAL OF THE SHORT LIST OF CONSULTANTS FOR CONSULTING SERVICES FOR THE STRUCTURAL EVALUATION AND ASSESSMENT AND STRENGTHENING / RETROFITTING OF NEA BUILDING

WHEREAS, the National Electrification Administration (NEA) posted the Request for Expression of Interest (REOI) for the Consulting Services for the Structural Evaluation and Assessment and Strengthening / Retrofitting of NEA Building in the NEA and PhilGEPS websites starting on 22 December 2018, and in a conspicuous place in the premises of the Procuring Entity continuously for 7 days;

WHEREAS, on 09 January 2019, in response to the said REOI, five (5) consultants submitted their Expressions of Interest (EOIs) together with their Eligibility Documents;

WHEREAS, on the same date, the Eligibility Check of the consultants was conducted in accordance with Section II of the Bidding Documents and pursuant to Section 24 of the Revised Implementing Rules and Regulation (IRR) of RA 9184. The BAC found four (4) consultants eligible for shortlisting namely: A.C Ong Consulting Inc., Enrique Olonan & Associates, Ernesto De Castro & Associates and GIBMA. *MJ Cañete Structural Engineering Consultancy*, however, was found to be ineligible due to non-submission of copies 1 and 2 of its eligibility documents;

WHEREAS, the BAC directed the Technical Working Group (TWG) to evaluate the Eligibility Documents of the eligible consultants for shortlisting purposes.

WHEREAS, on 28 January 2019, after careful deliberation and evaluation of the documents submitted by the eligible bidders, the TWG submitted its report to the Bids and Awards Committee (BAC) which shows the following ratings:

WHEREAS, in the said report, Enrique Olonan & Associates got a score of 36.66% which is 23.34% short of the minimum total score requirement of 60%, hence, did not qualify to be included in the shortlist. The other three (3) consultants got a rating score of higher than 60%.

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

a. To declare the following eligible consultants, who obtained ratings of more than 60%, as those comprising the short list for the Consulting Services for the Structural Evaluation and Assessment and Strengthening / Retrofitting of NEA Building:
