RESOLUTION NO. 40 s. 2020

Recommending Award of Contract for the "Lot II-Procurement of One (1) Unit Pick-up Truck"

WHEREAS, on 27 October 2020, the Invitation to Bid for the re-bidding of "Lot II-Procurement of One (1) Unit Pick-up Truck" was posted in the PhilGEPS and NEA website, in accordance with the 2016 Revised Implementing Rules and Regulations (IRR) of R.A. 9184;¹

WHEREAS, the amount of **One Million Six Hundred Thousand Pesos (Php1,600,000.00)**, as the Approved Budget for the Contract (ABC), was certified available by the Corporate Resources and Finance Services of NEA, chargeable against the **Motor Vehicles** funds of the 2020 Annual Procurement Plan (APP);²

WHEREAS, on 03 November 2020, the **Pre-bid Conference** was conducted thru video conferencing which was participated by the Bids and Awards Committee (BAC), Technical Working Group, BAC-Secretariat and two (2) prospective bidders participated, the Isuzu Automotive Dealership Inc. (Isuzu-Pasig) and Nissan Commonwealth;³

WHEREAS, on 05 November 2020, Isuzu-Pasig purchased the bidding document;⁴

WHEREAS, on 17 November 2020 at 8:15 a.m., Isuzu-Pasig submitted its bids prior to the deadline for **Submission of Bids** at 9:00 a.m.;⁵

WHEREAS, on the same date at 9:30 a.m., the **Opening of Bids** was held at 2nd Floor of the NEA building thru video conferencing which were participated by Isuzu-Pasig, BAC, TWG, BAC Secretariat and COA, as an observer;⁶

WHEREAS, using the non-discretionary "**pass / fail**" criterion, Isuzu-Pasig passed the eligibility, technical and financial component/requirements subject to verification and evaluation;⁷

WHEREAS, the financial bid proposal of Isuzu-Pasig was opened and its bid amounting to **One Million Six Hundred Thousand Pesos (Php1,600,000.00)** was found to be within the ABC of One Million Six Hundred Thousand Pesos (Php1,600,000.00);⁸

WHEREAS, by virtue of BAC Resolution No. 31, s. 2020, the BAC directed the TWG to conduct the **bid evaluation** of the financial proposal and **post qualification** of the eligibility, technical and financial documents submitted by Isuzu-Pasig pursuant to Sections 32 and 34 of the 2016 Revised IRR of RA 9184;⁹

WHEREAS, on 09 December 2020, TWG submitted its Bid Evaluation recommending Isuzu-Pasig as the Single Calculated Bid (SCB);¹⁰

WHEREAS, on the same date, the BAC sent the Notice of Post-Qualification to Isuzu-Pasig;¹¹

WHEREAS, on 28 December 2020, TWG submitted its Post-Qualification Report indicating that the eligibility, technical and financial requirements of Isuzu-Pasig were found to be responsive and therefore recommended to be the **Single Calculated and Responsive Bid (SCRB)**;¹²
