## CONTRACT

## SUPPLY, INSTALLATION, TESTING AND COMMISSIONING OF TAWELCO BARANGAY LINE ENHANCEMENT AND HOUSEHOLD CONNECTIONS

WHEREAS, the Entity invited bids/quotations for certain goods and ancillary services, particularly supply, installation, testing and commissioning of TAWELCO barangay line enhancement connections and has accepted a bid/quotation for the supplier for the supply of those goods and services in the sum of Twenty Nine Million Six Hundred Thirty Four Thousand Eight Hundred Eighty Nine Pesos and 21/100 and (₱29,634,889.21) (hereinafter called "the Contract Price").

## NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- V. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning contractor agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
