# RE-BIDDING OF THE PROCUREMENT OF SUPPLY OF ONE (1) YEAR FUEL, OIL, LUBRICANTS AND OTHER PRODUCTS/SERVICES FOR NEA VEHICLES

WHEREAS, on 16 January 2024, the Bids and Awards Committee through its BAC Secretariat, posted an Invitation to Bid for the above-stated project at PhilGEPS, NEA website, and conspicuous place, in accordance with Section 21.2 of the 2016 Revised Implementing Rules and Regulations (IRR) of R.A. 9184;

WHEREAS, representatives from three (3) agencies were invited to observe the conduct of the bidding process, namely: Ms. Emma A. De Guzman of the Commission on Audit, Mr. Anthony N. Marzan of KAISAHAN Tungo sa Kaunlaran ng Kanayunan at Repormang Pansakahan, and Mr. Ruben J. Pascual of the Philippine Chamber of Commerce and Industry;

**WHEREAS,** on 24 January 2024, a **Pre-Bid Conference** was conducted at the Cultural Affairs Room, 2<sup>nd</sup> Floor, NEA Bldg. and one (1) prospective bidder namely: Petawealth Gasoline Station;

WHEREAS, on 05 February 2024, the scheduled Submission and Opening of Bids was conducted at the Cultural Affairs Room (CAR), 2nd Floor, NEA Bldg.;

**WHEREAS,** during the scheduled **Submission and Opening of Bids**, Ms. Racquel Sibbalula of COA attended the BAC-proceeding;

WHEREAS, during the Opening of Bids, no prospective bidders responded to the bid for the Procurement of Supply of One (1) Year of Fuel, Oil, Lubricants, and Other Products/Services for NEA Vehicles amounting to Four Million Pesos (PhP 4,000,000.00)

**WHEREAS**, as per Section 35.1 (a) of the 2016 Revised Implementing Rules and Regulations of RA 9184, which stated that:

"The BAC shall declare the bidding a failure when:

(a) No bids are received;

**NOW, THEREFORE,** the members of the BAC hereby RESOLVED:

- 1. To declare failure of bidding; and
- 2. To recommend to the HoPE the conduct of the RE-BIDDING OF THE PROCUREMENT OF SUPPLY OF ONE (1) YEAR OF FUEL, OIL, LUBRICANTS, AND OTHER PRODUCTS/SERVICES FOR NEA VEHICLES with the same process and set the new periods according to the same rules followed during the previous bidding as per Section 35 of the 2016 Revised IRR of RA 9184.
