



BLACKLISTING ORDER No. 01, series of 2023

Pursuant to Sec. 69 of Republic Act No. 9184 and upon the findings and recommendation/s of NEA Special Bids and Award Committee and its Technical Working Group in its SBAC Resolution No. 001 s. 2023, the undersigned hereby issues this Blacklisting Order to the entity hereafter stated:

- Taurus Electrical Services with **PhilGEPS** Registration 20090338222847405184 having business address at Unit 2H Jojemar Bldg., 344 Maysilo Circle, Mandaluyong, Metro Manila together with Mr. Escorpiso. Proprietor. E. are hereby **SUSPENDED**/ **DISQUALIFIED** from participating in all government procurement – for one (1) year starting from 7 March 2023 until 7 March 2024
- 2. Specific grounds/offenses committed:
 - a. Failure of the contractor, due solely to his fault or negligence, to mobilize and start work or performance within the specified period in the Notice to Proceed (NTP).
 - b. Failure of the contractor to fully and faithfully comply with its contractual obligations without valid cause, or failure of the contractor to comply with any written lawful instruction of the procuring entity of its representative(s) pursuant to the implementation of the contract.
 - c. Willful or deliberate abandonment or non-performance of the project or contract by the contractor resulting to substantial breach thereof without lawful and/or just cause.
- 3. The penalty is being imposed in connection with the following procurement details:
 - a. Supply, Installation, Testing and Commissioning of TAWELCO Barangay Line Enhancement and Household Connections
 - b. Sibutu and Sitangkai, Tawi-Tawi
 - c. Contract Amount is Twenty Nine Million Six Hundred Thirty Four Thousand Eight Hundred Eighty Nine Pesos and 21/100

- 4. In addition to the foregoing, the following sanctions are also imposed:
 - a. Forfeiture of Performance Security in the amount of Eight Million Eight Hundred Ninety Thousand Four Hundred Sixty Six Pesos and 76/100 (PhP8,890,466.76)
 - b. Suspension of account in the PhilGEPS website.

The name of the foregoing person and/or entity shall be posted within three (3) calendar days from the date of effectivity of this Blacklisting Order in the Consolidated Blacklisting Report (CBR) through the Online Blacklisting Portal pursuant to Section 10 of the "Uniform Guidelines for Blacklisting of Manufacturers, Suppliers, Distributors, Contractors and Consultants", as amended by GPPB Resolution No. 14-2020 dated 25 June 2020. The names of the Blacklisted Person/Entity shall be removed upon the lapse of the period of penalty.
