The **BOHOL I ELECTRIC COOPERATIVE, INC. (BOHECO I)** will be conducting a Competitive Selection Process for the procurement of its 1.6-MW additional Long-Term (2021-2031) power supply requirement.

ELIGIBILITY REQUIREMENTS: To be eligible to participate in this Joint Competitive Selection Process, a bidder must exhibit control over generating capacity of power plant(s) with a certificate of good performance / track record from their customers.

TAKE-OFF STRUCTURE: These generating capacities may come from any type, size and number of power plants or generating units that are located and connected to Bohol Sub-Grid (138KV or 69KV) or directly embedded to BOHECO I's Distribution Network considering the respective limitations of its Substation and Distribution Lines.
