RESOLUTION NO. CSP-2024-07

A RESOLUTION DEFERRING THE CONDUCT OF SUBMISSION AND OPENING OF BIDS FOR THE LEYECO II POWER SUPPLY COMPETITIVE SELECTION PROCESS (L2-PSCSP) ORIGINALLY SET ON APRIL 29, 2024

WHEREAS, the Leyte II Electric Cooperative, Inc. (LEYECO II) is conducting a Competitive Selection Process (CSP) for the procurement of its 20MW Long-Term Baseload Demand for the period August 2024 to August 2034, pursuant to relevant laws and regulations;

WHEREAS, the Bids and Awards Committee (BAC) of LEYECO II is responsible for overseeing the procurement process and ensuring its transparency, competitiveness and fairness;

WHEREAS, the Bids and Awards Committee (BAC) has set the deadline for the submission and opening of bids on April 29, 2024;

WHEREAS, the National Electrification Administration (NEA), as the supervising agency of electric cooperatives, has called for a meeting on April 30, 2024, to discuss various issues that may adversely affect the proper conduct of the competitive selection process;

WHEREAS, it is of paramount consideration, and in the best interest of the procurement process to defer the submission and opening of bids to allow for the resolution of the issues to be discussed during the meeting with NEA;

WHEREAS, the new schedule will be announced the soonest possible time;

NOW, THEREFORE, BE IT RESOLVED, as it is hereby resolved by the Bids and Awards Committee of Leyte II Electric Cooperative, Inc. (LEYECO II) that:

- The submission and opening of bids for the Competitive Selection Process (CSP) for power supply procurement, originally scheduled for April 29, 2024, are hereby deferred until further notice.
- 2. The new schedule of the Submission and Opening of Bids will be announced the soonest possible time.
- The BAC shall convene promptly after the NEA meeting to assess the impact of the discussions on the procurement process and determine the appropriate course of action.
- 4. The BAC Secretariat is tasked with disseminating the Bid Bulletin for the deferment to all concerned parties and stakeholders.

GENTLEMEN:

This Office received your request for assistance from the National Electrification Administration ("NEA") regarding, among others, the following:

"We would like to bring some matters that we believe your office can assist us in positively resolving the following concerns:

- a. The EPSA of Region VIII Electric Cooperatives ["ECs"] that is near to expire and eventually expose us to the high price in the electricity market;
- b. The long term CSP that Region VIII [ECs] are now processing to commence where there are some issues that needed to be resolved before we will seek approval of notice to issue award;

We will appreciate if we can have your presence to discuss these important issues affecting the [ECs] that eventually affect the plight of the member-consumers who are electric consumers in our region." [Emphasis supplied]

The NEA's records disclose that there are currently two (2) Competitive Selection Processes ("CSPs") being conducted in Region VIII, the details are as follows:

Federation of Rural Electric Cooperatives of Region 8 ("FRECOR 8")	Pre-bid conference concluded last 23 April 2024 Submission of bids scheduled on 30 May 2024
Leyte II Electric Cooperative, Inc. ('LEYECO II")	Submission of bids scheduled on 29 April 2024







We note that the ECs which form part of your represented association/s are the main parties involved in the above-described CSPs. We further note the current circumstances which must be accounted for in the conduct of the said CSPs.¹

Relevantly, you and others have likewise made this Office aware of several issues which may supposedly adversely affect the conduct of the above-described CSPs, and could potentially jeopardize the supply of power in your Region.

This Office thus deems it proper to grant your request of providing assistance to ensure that the subject CSPs are concluded without issue at the soonest. You are therefore directed to confer with the NEA on 30 APRIL 2024, at 4:00 P.M. to discuss your matters raised. You are further directed to cascade this directive to all General Managers of the ECs subject of the above-described CSPs, as well as any and all other personnel whose presence you may deem necessary to the discussion to ensure that the said CSPs are properly conducted.

Please be guided accordingly.
